Persons interested in purchasing any of the specified residential properties must :-</p> <p>(a) personally attend the place where the sale will take place; and</p> <p>(b) bring along his/her H.K.I.D. Card(s) / Passport(s) and copy of Business Registration Certificate (if applicable) and cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) to be purchased by such person(s). Each cashier order shall be in the sum of HK\$300,000 and made payable to “MAYER BROWN JSM”.</p> <p>If a person interested in purchasing has successfully selected any of the residential properties, he/she will enter into a Preliminary Agreement for Sale and Purchase of the residential property(ies).</p> <p>For the purpose of determining the order of priority:-</p> <p>(a) On 9 January 2014, the Vendor does not accept any person having queued up before 2:00 p.m..</p>
