A 3% discount on the price would be offered to the Purchaser who is a SHKP Club member on the date of signing of the preliminary agreement for sale and purchase.

At that time, at least one director of the Purchaser should be a SHKP Club member in order to enjoy the discount offer.

All above offers (if any) and the approval or disapproval of the second mortgage loan is subject to the final decision of the Designated Financing Company.  If the Purchaser chooses to instruct his/her own solicitors to act for him/her in relation to the agreement for sale and purchase and the assignment, each of the Vendor and Purchaser shall pay his/her own solicitors' legal fees in respect of the agreement for sale and purchase and the assignment.
