Persons interested in purchasing any of the specified residential properties (“the registrant(s)”) must follow the procedures below:-

1. A registrant (if the registrant is a company, then one of its duly appointed directors) must submit **personally**:-
 - (a) only one Registration of Intent duly completed and signed by the registrant (if the registrant is a company, then signed by all its duly appointed directors for and on behalf of the registrant);
 - (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event (for registrant who is individual) shall not exceed three (3) or (in other cases) shall not exceed one (1). Each cashier order shall be in the sum of HK\$300,000 and made payable to “MAYER BROWN JSM”; and
 - (c) a copy of the registrant’s H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificateto 9/F, One International Finance Centre, 1 Harbour View Street, Hong Kong during 1 November 2013 to 2 November 2013 (from 3:00 p.m. to 9:00 p.m.); on 3 November 2013 (from 11:00 a.m. to 8:00 p.m.) and during 4 November 2013 to 6 November 2013 (from 3:00 p.m. to 9:00 p.m.).
2. All valid Registrations of Intent with price list nos.1 specified therein will be included automatically in this balloting. In case of dispute, the Vendor reserves its right to determine whether a Registration of Intent is valid and should be included in this balloting.
3. Each registrant shall only be registered under one valid Registration of Intent. Duplicated registration of registrant will not be accepted. Late submission will not be accepted. The Registration of Intent is personal to the Registrant and shall not be transferable.
4. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
5. For the purposes of maintaining order at the venue and/or facilitating smooth sale of the specified residential properties, the Vendor will determine whether there will be a single balloting or balloting in batches. The Vendor reserves the right at any time, for the purposes of maintaining order at the venue and facilitating smooth sale of the specified residential properties, to advance or postpone the time and date of balloting provided that the time and date of balloting will not be earlier than the closing time for submission of Registration of Intent under paragraph 1 above. Any changes to the time and date of balloting will be posted at the designated venue. Registrant(s) will not be notified separately of such changes.
 - (b) Registrant (if the registrant is a company, then all of its duly appointed directors) shall **personally** attend the designated venue on 8 November 2013 (3:00 p.m. to 3:30 p.m.) (the “reporting time”) for participating in the balloting. Any change of the reporting time as a result of change of the date and time of the balloting according to paragraph 6(a) above will be posted at the designated venue. Registrant(s) will not be notified separately of such changes. Registrant must bring along his/her original H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate and the original receipt of the valid Registration of Intent. Registrant(s) who arrives at the designated venue beyond the reporting time shall not be eligible to participate in the balloting and the subsequent selection and purchase of specified residential properties in accordance with paragraph 8 below.
 - (c) For each balloting, every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, less the number of specified residential property(ies) that has/have been purchased under that Registration of Intent. The number of specified residential property(ies) that the registrant(s) of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant(s) intends to purchase as indicated in that Registration of Intent, less the number of specified residential property(ies) that has/have been purchased under that Registration of Intent. The ballot results, including “registration number” and

“ballot result sequence” will be posted by the Vendor at the designated venue. Registrants will not be separately notified of the ballot results.

- (d) The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

7. The following shall apply if it is decided by the Vendor that balloting will take place in batches:

(a) First round balloting (for dividing all registrants into different groups)

- (i) The first round balloting will take place at the date and time as posted by the Vendor at the designated venue for the purposes of dividing the registrants into different groups. The Vendor reserves the right at any time, for the purposes of maintaining order at the venue and/or facilitating smooth sale of the specified residential properties, to advance or postpone the time and date of the first round balloting provided that the time and date of the first round balloting will not be earlier than the closing time for submission of Registration of Intent under paragraph 1 above. Any changes to the time and date of the first round balloting will be posted at the designated venue. Registrant(s) will not be notified separately of such changes.
- (ii) After the first round balloting, the registrants will be divided into groups and the registrants in each group will be eligible to participate in the second round balloting which will take place in batches.
- (iii) The results of the first round balloting, including “registration number”, “division of group”, “check-in timeslot for each group” will be posted by the Vendor at the designated venue. Registrants will not be separately notified of the ballot results.
- (iv) The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

(b) Second round balloting (for determining the order of priority of registrants in selecting and purchasing specified residential properties)

- (i) The second round balloting will take place in batches at such time(s) and date(s) as posted by the Vendor at designated venue. The Vendor reserves the right at any time, for the purposes of maintaining order at the venue and/or facilitating smooth sale of the specified residential properties, to advance or postpone the time and date of second round balloting provided that the time and date of the second round balloting will not be earlier than the posting of the results of the first round balloting mentioned in paragraph 7(a) above. Any changes to the time and date of the second round balloting will be posted at the designated venue. Registrant(s) will not be notified separately of such changes.
- (ii) Registrant (if the registrant is a company, then all of its duly appointed directors) shall **personally** attend the designated venue according to “check-in timeslot for each group” posted by the Vendor. Registrant must bring along his/her original H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate and the original receipt of the valid Registration of Intent. Registrant(s) who arrives at the designated venue beyond “check-in timeslot for each group” shall not be eligible to participate in the second round balloting and the subsequent selection and purchase of specified residential properties in accordance with paragraph 8 below.
- (iii) For the purpose of the second round balloting, every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, less the number of specified residential property(ies) that has/have been purchased under that Registration of Intent. 8. Subject to paragraph 9 below, after verification of the identity of the registrants (if the registrant is a company, also the identity of its directors), the registrants shall proceed to select and purchase the specified residential properties which are still available at the time of selection in the order of priority according to "ballot result sequence".

11. 以抽籤方式決定選擇住宅物業的次序。

有意購買任何指明住宅物業的人士(下稱「登記人」)須遵從下列程序：

1. 登記人(如登記人為公司，則其中一位已妥為委任的董事)須於 2013 年 11 月 1 日至 2013 年 11 月 2 日 (下午 3 時至晚上 9 時內)；2013 年 11 月 3 日(上午 11 時至晚上 8 時內) 及 2013 年 11 月 4 日 至 2013 年 11 月 6 日 (下午 3 時至晚上 9 時內)親身到香港港景街 1 號國際金融中心一期 9 樓，
 - (a) 遞交一份已填妥及由登記人(如登記人為公司，則所有已妥為委任的董事須代表登記人)簽署的購樓意向登記；
