A registrant must submit :- <ol style="list-style-type: none"> (a) only one Registration of Intent duly completed and signed by the registrant; (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed three (3). Each cashier order shall be in the sum of HK\$300,000 and made payable to “MAYER BROWN JSM”; and (c) a copy of the registrant’s H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate to 9/F, One International Finance Centre, 1 Harbour View Street, Hong Kong (“designated venue”) during 16 November 2013 to 18 November 2013 (from 1:00 p.m. to 8:00 p.m.). 2. All valid Registrations of Intent with price list no.2 (including the revised price list(s) thereof) specified therein will be included automatically in this balloting. In case of dispute, the Vendor reserves its right to determine whether a Registration of Intent is valid and should be included in this balloting. 3. If a registrant already holds a valid Registration of Intent and wishes to make the following changes to the said 	

Registration of Intent:-

- (a) changing price list number(s) specified in the said Registration of Intent; and/or
- (b) changing the number of residential property(ies) which the registrant intends to purchase,

the registrant (or his/her authorized person) must attend the designated venue during the time referred to under paragraph 1 above to replace the said Registration of Intent with a new Registration of Intent. The registrant shall bring along his/her original H.K.I.D. Card(s) / Passport(s) (or a copy of the H.K.I.D Card(s)/Passport(s) of the registrant if the new Registration of Intent is submitted by an authorized person) and (if applicable) copy of Business Registration Certificate and the original receipt of the valid Registration of Intent, and (if applicable) a valid authorization letter and a copy of the H.K.I.D Card/Passport of the authorized person. The procedures set out in paragraphs 1(a) and 1(b) above shall apply to the submission of new Registration of Intent.

- 4. Each registrant shall only be registered under one valid Registration of Intent. Duplicated registration of registrant will not be accepted. Late submission will not be accepted. The Registration of Intent is personal to the Registrant and shall not be transferable.
- 5. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
- 6. For the purposes of maintaining order at the venue and/or facilitating smooth sale of the specified residential properties, the Vendor will determine whether there will be a single balloting or balloting in batches. The details of the balloting method and the time and place for the balloting will be posted from 18 November 2013 (10:00 p.m.) to 19 November 2013 (12:00 noon) at the designated venue. Registrant(s) will not be notified separately.
- 7. The following shall apply if it is decided by the Vendor that there will be one single balloting:-
 - (a) The balloting will take place on 19 November 2013 at 3:00 p.m. at the designated venue. The Vendor reserves the right at any time, for the purposes of maintaining order at the venue and facilitating smooth sale of the specified residential properties, to adjust the time and date of balloting. Any changes to the time and date of balloting will be posted at the designated venue. Registrant(s) will not be notified separately of such changes.
 - (b) Registrant shall attend the designated venue on 19 November 2013 (2:00 p.m. to 3:00 p.m.) (the “reporting time”) for participating in the balloting. In case the designated venue shall become insufficient to accommodate all the registrants, the Vendor may for safety reason direct the registrants to attend such other venue by making suitable announcement at the reporting time at the designated venue. Any change of the reporting time as a result of change of the date and time of the balloting according to paragraph 7(a) above will be posted at the designated venue. Registrant(s) will not be notified separately of such changes. Registrant must bring along his/her original H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate and the original receipt of the valid Registration of Intent. Registrant(s) who arrives at the designated venue beyond the reporting time shall not be eligible to participate in the balloting.
 - (c) For each balloting, every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, less the number of specified residential property(ies) that has/have been purchased under that Registration of Intent. Once a lot allotted to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and be treated as null and void in the same balloting. The number of specified residential property(ies) that the registrant(s) of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant(s) intends to purchase as indicated in that Registration of Intent, less the number of specified residential property(ies) that has/have been purchased under that Registration of Intent. The ballot results, including “registration number” and “ballot result sequence” will be posted by the Vendor at the designated venue. Registrants will not be separately notified of the ballot results.
 - (d) The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.
- 8. The following shall apply if it is decided by the Vendor that balloting will take place in batches:
 - (a) First round balloting (for dividing all registrants into different groups)
 - (i) The first round balloting will take place at the date and time as posted by the Vendor at the

designated venue for the purposes of dividing the registrants into different groups. The Vendor reserves the right at any time, for the purposes of maintaining order at the venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the designated venue. Registrant(s) will not be notified separately of such changes.

- (ii) After the first round balloting, the registrants will be divided into groups and the registrants in each group will be eligible to participate in the second round balloting which will take place in batches.
- (iii) The results of the first round balloting, including “registration number”, “division of group”, “check-in timeslot for each group” will be posted by the Vendor at the designated venue. Registrants will not be separately notified of the ballot results.
- (iv) The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

(b) Second round balloting (for determining the order of priority of registrants in selecting and purchasing specified residential properties)

- (i) The second round balloting will take place in batches at such time(s) and date(s) as posted by the Vendor at designated venue. The Vendor reserves the right at any time, for the purposes of maintaining order at the venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of second round balloting. Any changes to the time and date of the second round balloting will be posted at the designated venue. Registrant(s) will not be notified separately of such changes.
- (ii) Registrants shall attend the designated venue according to “check-in timeslot for each group” posted by the Vendor. Registrant must bring along his/her original H.K.I.D. Card(s) / Passport(s) and (if applicable) copy of Business Registration Certificate and the original receipt of the valid Registration of Intent. Registrant(s) who arrives at the designated venue beyond “check-in timeslot for each group” shall not be eligible to participate in the second round balloting.
- (iii) For the purpose of the second round balloting, every valid Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent, less the number of specified residential property(ies) that has/have been purchased under that Registration of Intent. Once a lot allotted to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and be treated as null and void in the same balloting. The number of specified residential property(ies) that the registrant(s) of a successfully drawn Registration of Intent is entitled to purchase shall not exceed the number of specified residential property(ies) which such registrant(s) intends to purchase as indicated in that Registration of Intent, less the number of specified residential property(ies) that has/have been purchased under that Registration of Intent. The results of the second round balloting, including “registration number” and “ballot result sequence” will be posted by the Vendor at the designated venue. Registrants will not be separately notified of the ballot results.
- (iv) The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

9. After verification of the identity of the registrants, the registrants shall proceed to select and purchase the specified residential properties which are still available at the time of selection in the order of priority according to “ballot result sequence”.
10. If a registrant has successfully selected any of the specified residential properties, the registrant shall enter into a Preliminary Agreement for Sale and Purchase of the residential property(ies). Before entering into the Preliminary Agreement for Sale and Purchase in respect of any specified residential property, the registrant may notify the Vendor on spot to add any close relative (i.e. spouse, parent, child, brother and sister) as joint purchaser(s).
11. If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, his/her unused cashier order(s) will be available for collection by the registrant (or his/her authorized person) at 9/F, One International Finance Centre, 1 Harbour View Street, Hong Kong during 20 November 2013 to 21 November 2013 (from 1: 00 p.m. to 7:00 p.m.). The registrant

must bring along the H.K.I.D. Card(s) / Passport(s) of the registrant (or a copy of the H.K.I.D Card(s)/Passport(s) of the registrant if unused cashier order(s) is/are collected by the authorized person) and (if applicable) copy of Business Registration Certificate of the Registrant, the original receipt of the valid Registration of Intent, and (if applicable) a valid authorization letter and a copy of the H.K.I.D Card/Passport of the authorized person.

After the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the order of priority in the selection of the remaining specified residential properties (if any) will be on a first come first served basis. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).

On 20 November 2013 and thereafter:

Subject to the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the order of priority in the selection of the remaining specified residential properties (if any) will be on a first come first served. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).

2013 年 11 月 19 日：

以抽籤方式決定選擇住宅物業的次序。

有意購買任何指明住宅物業的人士(下稱「登記人」)須遵從下列程序：

1. 登記人須於 2013 年 11 月 16 日至 2013 年 11 月 18 日 (下午 1 時至晚上 8 時內)到香港港景街 1 號國際金融中心一期 9 樓(下稱「指定會場」)，
 - (a) 遞交一份已填妥及由登記人簽署的購樓意向登記；
 - (b) 購樓意向登記須附有本票，本票的數目需與登記人於購樓意向登記內填寫的意欲購買的住宅物業數目相同，惟該住宅物業數目不能多於 3 個。每張本票金額為港幣\$300,000 及抬頭人須為「孖士打律師行」；及
 - (c) 登記人的香港身份證/護照及(如適用)商業登記證書副本。
2. 所有有效的及指明價單 2 號(包括其經修改的價單)的購樓意向登記會自動被納入是此抽籤。如有爭議，賣方保留權利決定購樓意向登記是否有效及是否應被納入是此抽籤。
3. 如登記人已持有有效的購樓意向登記及欲對該購樓意向登記作出以下修改：
 - (a) 修改該購樓意向登記指明的價單號碼；及/或

6. 為了維持指定會場秩序及/或流暢地銷售指明住宅物業的目的，賣方會決定抽籤方式會以一次過或分階段進行。抽籤詳細程序、抽籤時間及地點會於 2013 年 11 月 18 日(晚上 10 時)至 2013 年 11 月 19 日(中午 12 時)於指定會場公布。登記人將不獲另行通知。
7. 如賣方決定進行一次過抽籤，以下程序適用：
 - (a) 抽籤程序將於 2013 年 11 月 19 日於下午 3 時於指定會場進行。為了維持指定會場秩序及流暢地銷售指明住宅物業的目的，賣方保留權利在任何時間調整抽籤程序的時間和日期。任何抽籤程序的時間和日期的修改會於指定會場公布。登記人將不獲另行通知該等修改。
 - (b) 登記人須於 2013 年 11 月 19 日下午 2 時至下午 3 時內(下稱「報到時段」)攜同其香港身份證/護照

正本及(如適用)商業登記證書副本及有效的購樓意向登記收據正本，到達指定會場參與抽籤。如指定會場不足以容納所有登記人，賣方可基於安全理由於報到時段於指定會場作出適當的公布，指示登記人前往其他會場報到。任何因根據上述第 7(a)段更改抽籤程序的時間和日期而修改報到時段，賣方會於指定會場公布。登記人將不獲另行通知該等修改。於報到時段以外的時間才到達指定會場的登記人將不享有參與抽籤的資格。

8. 如賣方決定進行分階段抽籤，以下程序適用：

(a) 第一輪抽籤(將所有登記人分為不同組別)

- (i) 第一輪抽籤程序將於賣方於指定會場公布之日期及時間進行，以將登記人分為不同組別。為了維持指定會場秩序及流暢地銷售指明住宅物業的目的，賣方保留權利在任何時間調整第一輪抽籤程序的時間和日期。任何第一輪抽籤程序的時間和日期的修改會於指定會場公布。登記人將不獲另行通知該等修改。
- (ii) 經過第一輪抽籤後，登記人會被分為不同組別，於不同時段參與分階段進行的第二輪抽籤程序。
- (iii) 賣方會將第一輪抽籤結果，包括「登記號碼」、「分組結果」及「每組別報到時段」將於指定會場公布。登記人將不獲另行通知抽籤結果。
- (iv) 如抽籤結果有任何錯誤或遺漏，賣方無須向登記人承擔任何責任。

(b) 第二輪抽籤(決定登記人選購指明住宅物業的優先次序)

- (i) 第二輪抽籤程序將於賣方公布之日期及時間於指定會場分階段進行。為了維持指定會場秩序及/或流暢地銷售指明住宅物業的目的，賣方保留權利在任何時間調整第二輪抽籤程序的時間和日期。任何抽籤程序的時間和日期的修改會於指定會場公布。登記人將不獲另行通知該等修改。
- (ii) 登記人須按賣方公布的「登記人報到時段」攜同其香港身份證/護照正本及(如適用)商業登記證書副本及有效的購樓意向登記收據正本，到達「指定會場」。於其「每組別報到時段」以外的時間才到達指定會場的登記人將不享有參與第二輪抽籤的資格。
